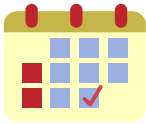
## Attendance

## Schedules



Classroom schedules will be distributed by teachers.

The schedule for *SJEDS at Home* students will be similar to students in the classroom. Teachers will provide schedules that will indicate the times students will need to Zoom in for synchronous learning. The schedules will also indicate time for asynchronous independent work and when they will not need to be on their devices. Students will have the opportunity to ask questions and interact with classmates. The schedule will also allow for time away from the computer for snacks, breaks, recess, etc.

## Lunch



Social distancing practices will apply during lunch. Teachers are also encouraged to use outside areas for lunch. Time for additional sanitization procedures has been built into the lunch schedules.

Students will eat lunch and rejoin the class at the scheduled time.

## Recess



Recess time will be limited to one group per area on the playground at a time. Time for sanitizing equipment has been built into the recess schedule. Creative games that encourage social distancing, such as pool noodle tag, will be encouraged.

*SJEDS at Home* students will take a break from screen time during scheduled recess time. Outdoor play is encouraged.

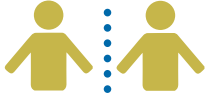
## Athletics



Athletics will be conducted in accordance with NFISAC league guidelines. *SJEDS at Home* students will not be permitted to participate in athletic and after school activities. When virtual students are comfortable returning to campus for school each day, they may join.

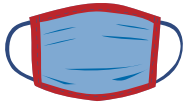
**Socially
